ABOUT THIS INSPECTION

The purpose of this inspection is to assure government, parents and the public of the quality of childcare and, if applicable, of nursery education. The inspection was carried out under Part XA Children Act 1989 as introduced by the Care Standards Act 2000 and, where nursery education is provided, under Schedule 26 of the School Standards and Framework Act 1998.

This report details the main strengths and any areas for improvement identified during the inspection. The judgements included in the report are made in relation to the outcomes for children set out in the Children Act 2004; the National Standards for under 8s day care and childminding; and, where nursery education is provided, the *Curriculum guidance for the foundation stage*.

The report includes information on any complaints about the childcare provision which Ofsted has received since the last inspection or registration or 1 April 2004 whichever is the later.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are inadequate - notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT SORT OF SETTING IS IT?

The childminder was registered in 1999. She lives with her partner and 18 year old child in the London Borough of Lambeth. The accommodation consists of a two bedroom house with access to a secure outdoor play area. The lounge and hallway are used for childminding and the bathroom facilities are situated on the first floor.

The childminder is registered to care for three children under five years and one child under eight years at any one time. The childminder has not cared for children since 2007.

When a provider does not have children on roll at the time of the inspection, inspection judgements are based on evidence gathered from discussions with the provider and an inspection of the premises, equipment and relevant documentation.

THE EFFECTIVENESS OF THE PROVISION

Helping children to be healthy

The provision is inadequate.

The childminder demonstrates a sound understanding of suitable procedures to:

promote children's health, by ensuring that positive steps are taken to prevent the spread of infection. However, the childminder has not completed first aid training, therefore the childminder is not qualified in first aid and the provision is inadequate. (National Standard 7: Health)

ensure that food and drink for children is adequate, properly prepared, nutritious and complies with dietary and religious requirements. (National Standard 8: Food and drink)

Protecting children from harm or neglect and helping them stay safe

The provision is satisfactory.

The premises are safe, secure and include the necessary facilities for children. The childminder demonstrates an awareness of how to ensure the environment is made welcoming to children. (National Standard 4: Physical environment)

The furniture, equipment and toys are safe and appropriate for the needs of children. (National Standard 5: Equipment)

The childminder understands how to promote children's safety and take precautions to prevent accidents. (National Standard 6: Safety)

The childminder has a sound knowledge of child protection procedures approved by the Local Safeguarding Children Board, and is aware of their responsibility to protect the welfare of the child. (National Standard 13: Child Protection)

Helping children achieve well and enjoy what they do

The provision is satisfactory.

The childminder has a satisfactory knowledge of how individual children develop and learn. (Standard 3: Care, learning and play)

Helping children make a positive contribution

The provision is satisfactory.

The childminder:

has an appropriate knowledge and awareness of the importance of treating each child with equal respect and concern (National Standard 9: Equal opportunities)

is aware that some children may have learning difficulties or disabilities, and understands the importance of working in partnership with parents and with other professionals to promote the welfare and development of the child (National Standard 10: Special needs)

shows a willingness and commitment to working with parents to manage children's behaviour in a consistent way which promotes the child's welfare and development (National Standard 11: Behaviour)

has a satisfactory understanding of the need to develop a strong partnership with parents, taking into account their differing needs. (National Standard 12: Working in partnership with parents and carers)

Organisation

The organisation is inadequate.

The childminder:

has not ensured that other people living or working on the premises are suitable to be in contact with children. (National Standard 1: Suitable person)

has not maintained a current first aid certificate. (National Standard 1.5: Qualifications)

understands the importance of working within the constraints of the condition of registration relating to number of children; and of organising space and resources to best meet the needs of the children. (National Standard 2: Organisation)

has a sound awareness of the records to be kept and the importance of these. (National Standard 14: Documentation)

Improvements since the last inspection

At the last inspection, the childminder agreed to develop her knowledge and understanding of Child Protection issues, ensure written parental permission was obtained for seeking emergency medical advice or treatment and before taking children on outings and public transport and to widen the range of multicultural books available to the children.

Appropriate steps have been taken to meet recommendations. The childminder has updated her knowledge and understanding of Safeguarding Procedures, has obtained the relevant consents and has increased the range of multicultural resources available to the children.

Complaints since the last inspection

Since the last inspection, there have been no complaints made to Ofsted that required the provider or Ofsted to take any action in order to meet the National Standards.

The provider is required to have procedures for dealing with concerns and complaints from parents and to keep a record of complaints and their outcome.

THE QUALITY AND STANDARDS OF THE CARE

On the basis of the evidence collected on this inspection:

The quality and standards of the care are inadequate - notice of action to improve. The registered person does not meet the National Standards for under 8s day care and childminding.

At the time of the inspection there were no children on roll. Ofsted judges that the provider remains suitable to provide care.

WHAT MUST BE DONE TO SECURE FUTURE IMPROVEMENT?

The quality and standards of the care

To improve the quality and standards of care, the registered person **must** take the following actions:

- complete a first aid course which includes training in first aid for infants and young children.
- ensure relevant checks are carried out on all adults living in and/or working on the premises

These actions are set out in a *notice of action to improve* and must be completed by the date specified in the notice.
